### 1. State Budget Update

**Issue**: The committee needs to review the Governor's State Budget.

**Discussion and Action**: Mr. Bonnet shared that in another 60 days, Governor Newsom will be releasing his proposed budget for the 2020-21 fiscal year (FY). The final recommendations from the Department of Developmental Services (DDS) concerning the recent service provider rate study will be released this month. The department has considered all of the input that they gathered during various meetings across the state. A majority of service providers will be receiving an 8.2% increase on January 1<sup>st</sup>.

Additionally, DDS is redesigning the DS Taskforce. The hope is that the group understands the various issues, as well as represents the entire community. The taskforce will be leaned on heavily for policy suggestions and system reform.

Regional centers are also seeking direction from DDS regarding the expectation that services will be provided in inclusive environments under the Home and Community-Based Services (HCBS) Settings Rule.

• In 2017, ACRC received 81 Fair Hearing (FH) requests, of which 17 cases went before the Office of Administrative Hearings (OAH). Last year, ACRC received 56 FY requests and 12 cases went before OAH. This calendar year, we have received 42 FY requests; 18 regarding eligibility and 24 regarding services. Eight cases have been decided by OAH.
