Kuv muaj kev zoo siab tau mus xyuas peb lub chaw ua haujlwm hauv Yuba City thiab ncig xyuas qee cov kev pab cuam zoo kawg hauv thaj chaw. Kuv kuj tau mus rau hauv chaw ua haujlwm Woodland thiab Roseville los ua kev zoo siab rau ib tus neeg ua haujlwm ntawm peb lub hlis uas tau txais txiaj ntsig zoo thiab noj su rau cov neeg ua haujlwm so haujlwm. 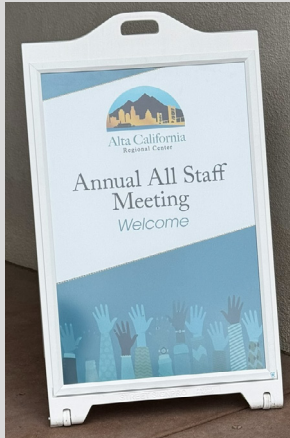
## KOJ PUAS TAU PAUB?

Eric kuj muaj ib txhia neeg uas tsis muaj zog kho mob, cov neeg uas muaj kev xav tau kev noj qab haus huv ntawm lub hlwb thiab teeb meem kev coj cwj pwm thiab tuaj yeem ua haujlwm nrog ntau pab pawg thiab cov kev pabcuam koom nrog.
