Without objection, Tom Hopkins made the motion to adopt the CAC meeting minutes of September 10, 2019 as submitted.


1. Executive Director's Report

- Phil asked for witnesses to Alta's Vision coming true.
 - Participating in the Special Olympics.
 - At their jobs they are valued employees.
 - Out in the community, when your caregiver treats you respectfully.
- Those present discussed past and present television shows and movies where individuals with disabilities were portrayed by those that have disabilities and actors in a positive light.
- Alta is entering into the world of social media. Soon we will have a Facebook page, Twitter feed and Instagram.
 - Suggestions include:
 - Posting more pictures on the agency's website; they will draw more attention (include clients and their families, CAC, employees, etc.).



- Possibly having a commercial or ad on TV or the radio.
- o Have staff share what they do and why they do it.
- Yesterday, Alta held a meeting to share information about the Self-Determination Program (SDP). Individuals that want to participate in this program need to attend an orientation by November 15th, or they will get dropped from the list. The Department of Developmental Services (DDS) will then choose replacements for the open slots.
 - The individual's team of support is critical to getting served under SDP.
 - Alta's first client has started SDP and a few more are almost ready.
 - DDS allocated 179 slots to Alta for the initial rollout of the three-year project. 52 people have chosen to be taken off the list, so we are waiting for the department to select their replacements.
 - Service Coordinators (SCs) are contacting the other participants to make sure they attend a scheduled orientation by the deadline.
- Last year for the holidays, the CAC helped the people of Paradise that were affected by the wildfire. At the November meeting, Phil will bring some suggestions for the committee to consider for this year.
 - If you have any suggestions, please let him know.

2. **Updates**



- Amy L. shared that the group met today and started planning for the next Regional Meeting, which will be held in March 2020.
 - A Touch of Understanding will be presenting.
 - Each group will be putting on a skit/roll play.
- PAN is now putting out a newsletter.
- They shared information about Chapter meetings.
 - The SLT People First Chapter is holding two dances:
 - The first one will be held on Saturday, October 19th, from 3:45 to 6:45 p.m.; you must R.S.V.P. by October 12th.
