RFP Projects:

EBSH (Project ID: ACRC-2324-4)-CRDP.

An Enhanced Behavioral Supports Home (EBSH) for 4 (four) adults ages 18-59 who require behavioral oversight.

RCFE (Project ID: ACRC-2324-5)-CRDP.

A Residential Care Facility for the Elderly (RCFE) for 4(four) adults ages 60+ who require nursing oversight/support.

FMS (Project ID: ACRC-2324-8)-CRDP

Financial Management Services (FMS) provider to support clients who choose to receive regional center services through the self-determination program (SDP), participant directed services, etc.

Out-of-Home Respite (Project ID: ACRC-2324-9)-CRDP

An after hours, center-based, out of home respite for up to 10 children at a time. This program will have an additional equity plan to support non-English speaking consumers and families.

Psychiatric Treatment-New Vendor (Project ID: ACRC-2324-11)-CRDP

Newly vendored psychiatrist to provide psychiatric treatment for individuals with ID/DD who have co-occurring mental health disorders.

Outpatient Substance Use Disorder Treatment (Project ID: ACRC-2324-12)-CRDP

An outpatient, substance use disorder treatment service for consumers with ID/DD and co-occurring substance use disorders.

Housing Access Services-New Vendor (Project ID: ACRC-2324-13)-CRDP

Housing Access Services for clients primarily living in outlining areas of ACRC service areas.

Enhance Supported Living Services (Project ID: ACRC-2324-14)-CRDP

Enhanced/Deflection Supported Living Services for either community-based or deflection adult clients that would benefit from an independent and/or unlicensed living environment due to their complex support needs (behavioral and/or medical).
